<b>CARRIER LIABILITY COVERAGE</b> Item 420	See Item 420 in the FedEx Freight and FedEx National LTL Rules Tariffs
<b>COLLECT ON DELIVERY (COD)</b> Item 430	COD amount to be collected - 6.0% of the COD amount, \$71 minimum charge, \$24 for changes to COD terms
<b>DETENTION</b> Item 500	With power - \$35.10 per 28' trailer each 15 minutes, \$62 minimum charge Without power - \$96 per 28' trailer each 24 hours
<b>EXHIBITION SITES</b> Item 520	Rated at Class 150, actual class or applicable exception class (whichever is greater) plus \$74 per shipment, see rule for additional charges to specific locations
<b>EXTRA LABOR</b> Item 560	\$63 per person per hour or fraction thereof, \$252 minimum charge
<b>EXTREME LENGTH</b> Item 530	\$52 per shipment when the shipment includes any piece exceeding 15 ft. in length
<b>HAZARDOUS MATERIAL HANDLING</b> Item 920	\$15 per shipment
<b>INSIDE PICKUP OR DELIVERY</b> Item 566	\$6.98 per cwt., \$73 minimum charge, \$739 maximum
<b>LIFTGATE SERVICE</b> Item 890	See Item 890 in the FedEx Freight and FedEx National LTL Rules Tariffs
<b>LIMITED ACCESS PICKUP OR DELIVERY</b> Item 750-8	\$76 per shipment (Includes: construction sites, mine sites, churches, schools, etc.)
<b>MARKING OR TAGGING FREIGHT</b> Item 580	\$3.35 per package or piece, \$47 minimum charge
<b>NON-BUSINESS TIME SERVICE</b> Item 753	\$104 per person per hour or fraction thereof, the minimum charge for non-business hours is \$210, non-business days \$389
<b>NOTIFICATION PRIOR TO DELIVERY</b> Item 750-3	\$32 per shipment
<b>PROTECTION FROM FREEZING SERVICE</b> Item 810	\$1.81 per cwt., \$18 minimum charge (available in selected areas only)
<b>REDELIVERY</b> Item 830	\$7.34 per cwt., \$73 minimum charge, \$769 maximum per shipment
<b>RESIDENTIAL PICKUP OR DELIVERY</b> Item 750-2	\$76 per shipment
<b>SORTING AND SEGREGATING</b> Item 887	\$1.67 per cwt. or \$0.62 per piece, whichever produces the higher charge, \$68 minimum charge
<b>STORAGE</b> Item 910	\$2.10 per cwt. per day, minimum charge \$20 per shipment per day, not less than \$73 per shipment, see rule for maximum charges
